### Welcome to Anthony Country Club



Established over 80 years ago, Anthony Country Club is the only nine-hole private country club in the El Paso- Las Cruces Region.

The Club hosts the Anthony Invitational since 1946, which is considered one of the Majors in the region's tournament history, a match play tournament that requires the champion to grind out up to 5 rounds in 4 days.

Located on the banks of the Rio Grande, the course provides an excellent challenge to all golfers, no matter the skill level.

#### Club Amenities:

##### Golf Course:

Anthony Country Club offers a 9-hole golf course that can be played as 9 holes or 18 holes, as each hole has two sets of tee markers to play from. Golf carts are available for rental, cart rentals are not part of the monthly membership dues. Members are allowed to bring in their private carts, but they must pay quarterly trail fees and storage fees if they are stored on-site. Private carts must follow the general cart rules set for the rental carts. Guests are welcome to join the members, guest fees are posted in the clubhouse. We plan monthly member tournaments for all golfers, no matter their ability.

##### Clubhouse:

The Clubhouse has a full bar facility open to the membership Tuesday through Sunday. In addition to the bar, Chefita's Kitchen is open daily for breakfast and lunch. There is a Ladies and a Men's locker room available to the membership. Also we have the 19<sup>th</sup> Hole, an area for members and guests to sit and watch the game, play cards, or just to hang out.

##### Club Hall:

The club has a hall with an attached kitchen to host your special event. Members receive a reduced rate to rent the hall, which hosts lunches, dinners, weddings, birthday parties, etc. The membership also will enjoy a club hosted pot-luck dinner for the membership throughout the year, with the special occasions on Fourth of July, Thanksgiving and Christmas.

##### Pool:

The pool is typically open by Memorial Day and remains open through Labor Day Weekend. The pool is open to members and their guests will pay a guest fee. The pool is available for rent for private parties as well.

##### Membership:

Potential members will require sponsorship by an existing member in good standing. All new memberships are reviewed at the Board of Director's monthly meeting for approval. Dues and fees are billed quarterly and must be paid by the end of the billed quarter. Members more than 30 days in arrears will be suspended until dues are caught up.

# *Member Code of Conduct*

## Introduction

The intention of this document is to establish clear and acceptable behavior expectations for the Anthony Country Club members and guests. It is not intended to restrict the rights of anyone, but rather to ensure that all members and guests can expect to be treated with respect while enjoying the Anthony Country Club golf course and clubhouse. This Code of Conduct is available electronically, posted at the Clubhouse and upon request from any Member. The club deems that upon payment of membership or green fees, all members and guests have given their consent to be bound by both the restrictions and penalties imposed by this code of conduct.

ACC discourages any form of racial, sexual, religious, or other discrimination and this Code of Conduct is aimed at promoting protection of all Members, guests, Board Members and employees. Violations of these rules should be reported directly to Club Management or a Board Member.

## Code of Conduct

All members and guests shall:

- Conduct themselves in a sportsmanlike manner – behaving in a way that is fair and shows respect toward the other players when playing sports.(i.e. Will not knowingly cheat, throw clubs, disrespect employees, officials, or fellow competitors.
- Respect the rights of other players and golf course staff (i.e., Will not verbally or physically threaten or slander others, either personally or through social media, harass, either sexually, physically, or verbally or in any manner which has been relayed as being offensive or unwanted any Member, employee or guest)
- Observe proper golf etiquette as well as USGA and local rules of the course. (Ex: following cart signs, or not hitting into the group in front of you)
- Respect the golf course, golf carts and facilities.
- Adhere to all club rules, including, but not limited to the following:
  - o Sign in procedures in the Golf Shop
  - o Rental and safe operation of carts in designated areas only
  - o Seeking staff approval for starting on any hole other than number 1
  - o Obeying all signage on the golf course
  - o Take pride in the physical appearance of the Anthony CC
  - o No outside alcoholic beverages are permitted on club property (NM State Statute 60-7A-13)
- Conducting themselves in a respectful manner by not engaging in any rude or immoral conduct, including the use of disrespectful language, gestures, insults, or other such misbehavior.
- Abide by all state, local and federal laws and regulations, including the possession of any illegal drugs and weapons on the property of the Anthony Country Club
- Be an ambassador for the Anthony Country Club when out in the community or at other clubs, we are all representatives of Anthony Country Club
- Use of social media, including, but not limited to FaceBook, WhatsApp and the Website is a privilege and not a guaranteed part of your Membership benefits. Conduct that is contrary to this Code of Conduct or communications intended to promote negative opinions shall be avoided. Failure to conduct oneself in accordance with this Code of Conduct may result in termination of your privileges of use.

## Resolution of violations to the Anthony Country Club Code of Conduct

- Upon a report of a violation of this Code of Conduct, the item shall be placed on the Board Meeting Agenda for closed-session discussion. In the event that remedial actions are to be considered, the “offender(s)” shall be notified of the claim and shall have (7) business days to respond or request a closed session discussion of the issue.
- After discussion and consideration, the Board may take such actions as 1) limiting privileges for an adequate time period without reimbursement to the offending member 2) terminate membership; or 3) other such relief, including monetary compensation to the Club for damages, as are deemed adequate for the offense. In all cases should there be damage to property, monetary restitution will be mandatory to continue membership.
